BACKGROUND INFORMATION

History: These items were donated as part of the Maroa Public Library materials, when the library moved all local history into the MF School Archives. The accession number of these papers reflects that they came in with all the Maroa Public Library materials. General materials within the Maroa Public Library collection have accession number 2021.05. No specific history is known as to when Janet Parker's papers were added to the Maroa Public Library local history materials.

Scope and Content: Janet Parker papers were donated when the Maroa Public Library moved all Maroa historic items into the MF School Archives. Parker's papers were all boxed together and included family histories, books relating to various branches of family genealogy, some photographs, and some handwritten notes. The items were refoldered and reboxed. Items were kept together that were found clipped or enveloped together in the original box. Bound books were placed with in the reference library (see Separated Items section of Finding Aid). Photographs were placed in protective sleeves.
